By car

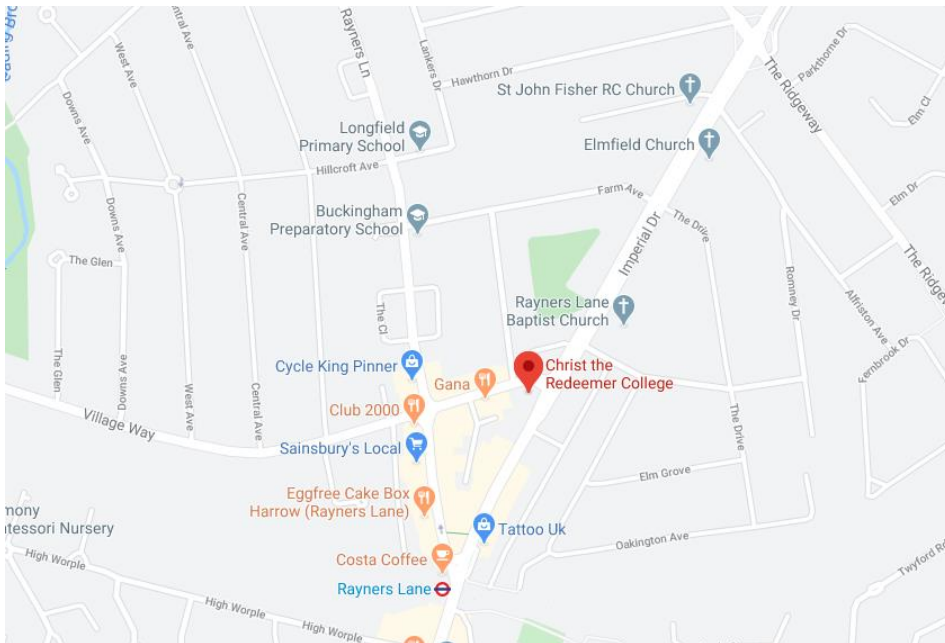
- Postcode for satnav: HA2 7LX

Programme Summary

The purpose of Pearson BTEC Higher Nationals in Business is to develop students as professional, self-reflecting individuals able to meet the demands of employers in the business sector and adapt to a constantly changing world. Language of instruction: English

Credits:	120 credits per year; Eight 15-credit units (or part-time equivalent). The exception to this is Unit 11 - Research Project at Level 5 which is worth 30 credits.
Teaching:	The College expects students to undertake 150 learning hours for each unit, of which 60 credits will be guided learning hours (GLH). Guided Learning Hours (GLH) are defined as the time when a tutor is present to give specific guidance towards the learning aim being studied on a programme. This definition includes lectures, tutorials and supervised study in, for example, open learning centres and learning workshops. Guided Learning includes any supervised assessment activity; this includes invigilated examination and observed assessment and observed work-based practice.
Assessment:	Each unit sets out the Pass, Merit and Distinction criteria for that unit. When assignments are graded, a tutor will refer to this table, which connects the unit's Learning Outcomes with the student's work.

3. Documents to bring with you

All documents must be originals, not copies or scans. If your documents are incomplete, you will not be able to complete all the necessary tasks, which could delay your application.

1. **ID documents:** All applicants must provide ID/residency documents
 - Passport: This must be current.
 - Residency permit, if applicable.
 - Any name-change deeds.
 - Driving licence: If you have a driving licence, whether full or provisional, you must produce this.
 - Proof of your current address
 - Proof of your National Insurance (NI) number

2. **Certificates:** You must provide certificates for any academic qualifications which you wish to use in support of your application.
 - If you have lost your certificates and want to get replacements, you can find out how to do so at: <https://www.gov.uk/replacement-exam-certificate>.

3. **Photo:** You must provide a passport-style photo which a member of the College staff can verify against your ID and which can be used for your student ID card and College profile.
 - A photo taken on an iPad or good quality phone camera is fine.
 - If you do not bring a photo, please make sure that you have one taken when you come for your interview.

4. **Application Fee:** Please remember to bring your £25 application fee with you when you visit the College.

4. Preparing for your admissions interview

Your interview will last about half an hour. In addition, there will also be a written assessment. To make the most of that time and your visit to the College, you should prepare carefully.

We suggest that you read about the course of study that interests you and think about:

- Your reasons for wanting to do the course;
- How you would like the course you have chosen to develop future employment;
- Any questions you would like to ask.
